2. Accordingly, sealed quotations are invited for the disposal of above stated items on the terms and conditions in the enclosed proforma. The quotation may be submitted to the Director, Indian Institute of Handloom Technology, Jawahar Nagar, Khanapara, Guwahati on or before 20-10-2025 upto 3:00 PM. The quotations received in the fixed time will be opened at 3:30 PM on the same day. The cover should be prominently super scribed with the words **"QUOTATION FOR PURCHASE OF CONDEMNED SCRAP"**. The condemned scrap will be available for inspection between 2:30 PM to 5.00 PM on 16-10-2025 to 17-10-2025.

3. The quotation received in time will be opened at the Chamber of Director, IIHT, Jawahar Nagar, Khanapara, Guwahati. The bidders or their representative (not more than one) may remain present, if they so desire, at the time of opening of quotation.

4. The auction will be governed by the following conditions:-

- a) The bidder is requested to Earnest Money Deposit (EMD) of Rs.500/- (Rupees Five Hundred) only payable by means of Demand Draft in favour of Director, IIHT, Guwahati.
- b) Quotation received without Demand Draft towards EMD will not be considered.

- c) The successful bidder will be required to deposit the bid amount by means of Cash/Demand Draft drawn in favour of Director, IIHT, Guwahati.
- d) The EMD of the successful bidder will be released only after the deposit of sale proceeds. EMD will be forfeited, if he fails to honour the bid.
- e) The delivery of the scrap items will be arranged only after the successful bidder submit documentary evidence in support of residential status viz., Ration Card / Voter Identity Card/ Passport in case of individual and Registration Certificate in case of firms etc.
- f) The items will have to be removed by the successful bidder within two days of depositing the bidding amount at their own expenses.
- g) The items will be disposed of on as is where basis and no guarantee for its worthiness or quality will be given by this office.
